which the said George B Holliman doth hereby acknowledge. And as this Indenture witnesseth
that for and in consideration aforesaid as well as for the further consideration of one
dollar in hand paid by the said Phineas M Bailey to the said John Brown at and
before the executing and delivery of these presents the receipt whereof is hereby acknowledged
by the said John Brown with the dissent and approbation of the said George B Holliman
signified by his being party to these presents, and the said George B Holliman have granted
bargained and sold remised released and confirmed, and by these presents do grant bargain
sell remise release and confirm unto the said Phineas M Bailey all the estate right title
interest claim and demand both at law and in equity which the said John Brown and George
B Holliman have or hold in the land above described. To have and to hold the said tract or
parcel of land to the said Phineas M Bailey his heirs, executors &c forever to the only proper
use and behoof of him the said P. M Bailey his heirs, executors, administrators & assigns forever
and the said John Brown and George B Holliman for themselves their executors & administra-
tors the above mentioned land unto the said P. M Bailey his heirs, executors, administrators &
assigns in so full and ample manner, as the same was warranted by the said Phineas M
Bailey by the deed of trust above recited, do warrant the same to the said P. M Bailey against
the claim or claims of them the said John Brown and George B Holliman and all persons

This Indenture made and entered into the 22^d day of April in the year of
our Lord 1843, between Joseph Pattison of the first part Phineas M Bailey of the
second part and George B Holliman of the third part. Whereas the said Phineas M
Bailey on the 15th day of January in the year of our Lord 1843 in order to secure the pay-
ment of a bond due William B Holliman for two hundred and fourteen dollars and thirty
eight cents, also one bond due Gray Carroff of the sum eighty eight dollars and eighty
nine cents, also another bond due James Clayton for the sum of ninety five dollars
and thirty one cents all of the above bonds and sums the said George B Holliman
