Holliman, Greig Bassel and James Clayton the several sums of money thereby secured which the said George B Holliman doth hereby acknowledge Now this Indenture witnesseth, that for and in consideration aforesaid, as well as for the further consideration of one dollar in hand paid by the said Phineas M. Bailey to the said Joseph Putton, at and before the executing and delivery of these presents, the receipt whereof is hereby acknowledged by the said Joseph Putton with the assent and approbation of the said George B Holliman, signified by his being party to these presents, and the said George B Holliman have granted, bargained and sold confirmed released and confirmed, and by these presents do grant bargain & sell remain release and confirm unto the said Phineas M. Bailey all the estate, right title interest claim and demand, both at law and in equity, which the said Joseph Putton & George B Holliman have, or hold in the land above described. To have and to hold the said tract or parcel of land, to the said Phineas M. Bailey, his heirs, executors & assigns to the only proper use and behoof of him the said P^m. Bailey, his heirs, executors, assigns & assigns forever. And the said Joseph Putton and George B Holliman for themselves, their heirs executors & assigns do the above mentioned land, unto the said P^m. Bailey his heirs executors administrators and assigns, in as full and ample manner as the same was warranted by the said Phineas M. Bailey by the deed of trust above recited, do warrant the same to the said P^m. Bailey against the claim or claims of them the said Joseph Putton and George B Holliman and all persons claiming by or under them or either of them.
