This Indenture made and entered into this 21st January in the year
 1843, between James H Person & of the one part, James James and wife Sarah A M.
 of the second part, and Mark A James of the third, all of the County of Southampton
 and State of Virginia. (Witnesse) that whereas James James and wife Sarah on the 19th
 July in the year 1841, in order to secure the payment of a bond, due to Joseph T Gau
 for the sum of twelve hundred dollars on demand the same day with the lawful debt the
 might accrue thereon, did convey to James H Person trustee, a tract or parcel of land
 lying and being in the County of Southampton bounded by the lands of Benj Turner's Estate
 David Turner's land, Henry Harrison's and the flat swamp - containing two hundred
 & thirteen acres to the same more or less, also two negro slaves by name Jenny & Lucy for the
 uses and purposes, in the said indenture mentioned. And whereas the said James James
 & wife failed to make any payment on said bond either in part or the whole and upon
 such default the said tract of land, and improvements, being exposed to public sale
 on the premises on Wednesday the 18th Inst for cash by notice given by James James &
 the written consent of said James & his wife Sarah also of Joseph T Gau, William
 L Orrill, and Mark A James became the purchased of said land and premises
 for the sum of twelve hundred & nine dollars. Now this indenture further witnesseth
 that the said James H Person trustee as aforesaid for and in consideration of monies
 due, and for the further consideration of twelve hundred and nine dollars to him in hand
 paid by the said Mark A James at and before the sealing and delivery of these
 presents the receipt whereof is hereby acknowledged, doth give grant bargain and sell
 unto the said Mark A James & his heirs and assigns forever, the tract of land and
 improvements, described before in this indenture containing two hundred and thirteen
 acres to the same more or less and the said James H Person trustee doth hereby command
 and agree to and with the said Mark A James, that for himself as trustee that
 he will warrant such right and title as is vested in him by virtue of the before
 mentioned deed of trust, and that right only unto him the said Mark A James
 & his heirs forever against the claim & demands of himself or any other person clai-
 ming by or under him - and the said James James and wife on their part doth hereby
 covenant and agree to and with the said Mark A James that they do by these
 presents convey all title but and benefit they may have in said land and improve-
 ments unto him the said Mark A James & his heirs forever, and that they will warrant
 and defend the same against themselves their heirs or any person claiming under
 them. In Testimony whereof the said James H Person trustee, and the said James James

 above written.
