Witnesseth that the said Sarah Turner in consideration of the sum of fifty dollars & 00/100 to her in hand by the said John B. Sherrod at or before the delivery of these presents. (the receipt whereof is hereby acknowledged) have bargained & sold and by these presents doth bargain & sell to the said John B. Sherrod his heirs & assigns all my interest in a certain tract of land known by the name of Watts meek containing two hundred & thirty seven acres, adjoining the lands of Joseph B. Claud, Nathl Jones, James Jackson & others, the land lying and being in the County of Southampton & State of Va. together with all & singular the appurtenances therunto belonging or in any wise appertaining. To have and to hold the said land & therein before mentioned or intended to be bargained & sold & every part and parcel thereof, unto the said John B. Sherrod, his heirs & assigns, to and for the only proper use & behoof of them, the said John B. Sherrod his heirs & assigns. And the said Sarah Turner doth for herself & her heirs, warant and defend the premises and appurtenances before mentioned, unto the said John B. Sherrod his heirs & assigns free from the claim or claims of herself, her heirs and of all and every person or persons whatsoever.
