Therefore the said William Beale do and in consideration of the sum of nine hundred & forty seven dollars to him in hand paid by the said Edwards Beale (the receipt whereof is duly acknowledged) doth grant, bargain and sell, assign, and relinquish unto the said Edwards Beale all the right title claim title or demand whatsoever which he the said Beale under the said bond doth possess to, whether at law or equity he absolutely or is remembered in the monies now belonging to the Estate of Peter North, which in the hands of Edwards Beale's administration do lie now with the will annexed of the said Peter North or in the hands of any other person or representative of the said Peter North do also at the right of every interest claim or demand whatsoever which in the said William Beale has or may hereafter have either at law or in equity, in and to any monies which are now due or which at any time hereafter may be due or owing or to which the Estate of the said John North (in what character so ever) representative thereof or his distributees or those claiming under them are or may be entitled to or receive from the Estate of Peter North or from Edwards Beale's administrator do lie now with the will annexed of Peter North or from any other representatives of the said Peter North or from any other person indebted to or having monies in their hands belonging to the Estate of the said Peter North. Off here and to hold the interest above conveyed or intended to be conveyed to him the said Edwards Beale he or his heirs and assigns against the right title claim or demand of the said William Beale and all other persons or persons whatsoever.
