This Indenture made and entered into this 20<sup>th</sup> day of February A.D. 1825 between Littleton R Edwards of the County of Southampton and Thomas C Jones & Martha his wife of the Town of Portsmouth of the County of Norfolk of the one part and William J Schell and Nicholas M Schell of the County of Southampton of the other part. Whereas Thomas C Jones and James H Selbelle by an indenture bearing date the 1<sup>st</sup> day of March 1819 and admitted to Record in the Clerk's Office of the County of Southampton aforesaid on the 20<sup>th</sup> day of April 1829 for the purpose of indemnifying and securing William J Schell (and) Nicholas M Schell against all and every loss or damage whatever in consequence of this being the said Thomas C Jones & James H Selbelle security to certain demands and indenture mentioned as described did runny unto the said Littleton R Edwards amongst other property the following to wit two lots with clay building and improvements thereon of every description situated in the town of Portsmouth and designated in the plan of said Town as Lots 15 & 19 which two lots he were conveyed to the said Thomas C Jones & James H Schell by Deed No 90 Vaughan by deed dated the 1<sup>st</sup> day of January 1829. Upon trust and with power and authority to the said Littleton R Edwards upon being acquainted to be by the said William J & M Schell their lessors and/or assigns to make sale of the aforesaid property at public auction to the highest bidder for cash for the purpose of paying the debts mentioned in the said Indenture for which they were security or reimbursing them any amount they may have had to pay with interest thereon. And whereas the said Littleton R Edwards having been acquainted to be by the said William J & M Schell and having fixed no time or place of sale and given reasonable public notice thereof did on the day set up and sell at public auction to the highest bidder for cash the aforesaid Lots No 15 & 19 with the building and improvements thereon of every description and at the sale to make the aforesaid William J Schell & Nicholas M Schell because the purchasers of the said Lots No 15 & 19 by bidding therefor the sum of five hundred dollars which was the highest bid made for the same. Now therefore this indenture witnesseth that the said Littleton R Edwards & Thomas C Jones & Martha his wife for and in consideration of the premises as well as for the further consideration of the said sum of five hundred dollars to be paid Littleton R Edwards is bound paid by the said William J & Nicholas M Schell the receipt whereof is hereby acknowledged have granted bargained & sold and by these presents do grant bargain & sell unto the said William J Schell & Nicholas M Schell the lots herein before mentioned with the building and improvements of every description thereon to have and to hold the before mentioned premises unto the said Wm Schell & Nicholas M Schell their heirs and assigns forever. And the said Littleton R Edwards & Thomas C Jones & Martha his wife hereby warrant & defend the title & right of record to the premises unto them the said William J & Nicholas M Schell their heirs & assigns against themselves the said Littleton R Edwards & Thomas C Jones & Martha his wife and against their claiming the same or any part thereof by through or under them only. In witness whereof the said Littleton R Edwards & Thomas C Jones & Martha his wife have hereunto at this hands affixed their seals the day & year first aforesaid.
