This Indenture made this 20th day of August one thousand eight hundred and forty three between Sethus Charles of the County of Southampton and State of Virginia of the one part and Eli Drake of the other part, witness that the said Sethus Charles, for and in consideration of the sum of fifty dollars to him in hand paid by the said Eli Drake, the receipt whereof is hereby acknowledged himself fully satisfied and paid hath granted hereunto and sold one certain tract or parcel of land lying and being in the County of said Southampton containing by estimation sixteen acres to the same more or less and bound as follows to wit Beginning at a corner tree in the said Sethus Charles land thence a line of marked trees to a hick a corner tree in the said Charles line thence a straight line of marked trees to a hick a corner tree thence a straight line of marked trees to the first Station, I gathered with all the houses out houses ways water ways water across orchard garden & belonging in any ways appertaining. To have and to hold the said land to him the said Eli Drake to him and his heirs forever, and the said Sethus Charles doth warrant and defend forever by these presents any person claiming or demanding the same or any part thereof the testimony whereof the said Sethus Charles have hereunto set his hand & affix his seal this day and date first above written.
