Bryant (165) one Bond for the sum of four hundred and sixty three dollars and twenty six Cents payable the 1st day of April 1844 with interest from the 1st day 1843 and one other Bond made payable to the same for four hundred and sixty three dollars and twenty six Cents payable and on demand the 1st day of April 1845 with interest from the 1st day last before the 16th day of October 1843 and the said Wm L.
