This Indenture made and entered into this 14th day of Nov^r 1863 between Edwin B. Blood and Martha his wife of the County of Southampton of the first part and Francis S. Jones of the second - Witnesses that for and consideration of the sum of Four hundred and five dollars to them in hand paid the receipt whereof is hereby acknowledged by them they the S^d Edwin B. Blood and wife have bargained and sold unto by these presents to be given and sold to the S^d Francis S. Jones a certain tract or parcel of land situate in the County afores^d and bounded as follows beginning at a red oak in the road a corner for S^d Blood on S^d Jones line thence S^d Blood to a post a corner for S^d Jones in Albert L. Ross line thence his line to a Black gum in the run of a small branch a corner for S^d Jones & Blood in Edwin B. Bloods line down the run of S^d branch to a water oak a corner for S^d Jones & Blood on the S^d Jones line on a swamp thence his line down the run of S^d swamp to a dead Maple a corner of S^d Blood and Jones on Benj^l Williamsens line thence S^d Jones line to the first station containing by recent survey one Acre and thirty five cents to the same run a dip to have and to hold the tract of land afores^d with the appurtenances to them the S^d Francis S. Jones his heirs &c in absolute fee simple estate and the S^d Edwin B. Blood and wife Covenant with the S^d Francis that he and they shall have and enjoy a good title to the S^d granted premises with possession of the same free from the claims of all persons Whatsoever.
