This Indenture made and entered into this 14th day of Nov^r 1863 between Edwin B. blood and Martha his wife of the County of Southampton of the first part and Francis S. Jones of the second- Witnesseth that for and consideration of the sum of Four hundred and five dollars to them in hand paid the receipt whereof is hereby acknowledged by them they the S^d Edwin B. blood and wife have bargained and sold unto by these presents do bargain and sell to the S^d Francis S. Jones a certain tract or parcel of land situate in the County aforesaid and bounded as follows beginning at a red oak on the road a corner for S^d blood on S^d Jones line thence S^d blood to a post a corner for S^d Jones in Albert B. Ross line thence his line to a Black gum on the run of a small branch a corner for S^d Jones & blood in Edwin B. blood's line down the run of S^d branch to a water oak a corner for S^d Jones & blood in the S^d Jones line on a swamp thence his line down the run of S^d swamp to a dead Maple a corner of S^d blood and Jones in Bangs Williams line thence S^d Jones line to the first station containing by recent survey one hundred and thirty five acres to the same now to be known and to hold the tract of land aforesaid with the appurtenances to them the S^d Francis S. Jones his heirs &c in absolute fee simple estate and the S^d Edwin B. blood and wife Covenant with the S^d Francis his heirs &c that he and they shall have and enjoy a good title to the S^d granted premises with possession of the same free from the claims of all persons whatsoever.
