Know all men by these presents that I Hammett Whitehead of the County  
of Southampton and State of Virginia for and in Consideration of the Natural  
law and affection which I bear to Nathaniel Francis of the County and  
State aforesaid as well as for the further Consideration of eight hundred dollars  
to me in hand paid by the said Nathaniel Francis when before the sealing  
and delivery of these presents the receipt whereof is hereby acknowledged  
have given and granted and by these presents do give and grant unto the  
said Nathaniel Francis his heirs executors administrators and assigns the  
following property to wit: the tract of land on which I live together  
with its appurtenances belonging thereto containing by survey Five  
hundred and sixty acres to the same more or less adjoining the lands  
of John G. Turner Richard Porter Joseph Benson Edwin Harris and  
others also one Negro man Huckle one Negro boy named one day George  
one Negro woman Dandy and two children Jane and Willis one ....  
Woman Kennedy and Child Bob and all the future increase of said Negroes  
all my stock of horses cattle sheep and hogs and all their increase  
all my Crops of Corn, Foster, Potatoes, Peas and Cotton and one horse  
and Brough and harness with all my farming utensils. To have and  
to hold all the aforesaid Land Negros stock of every kind and their  
increase with ~~the~~ before named unto him the said Nathaniel  
Francis his heirs executors Administrators and assigns forever and the said Hammett  
Whitehead for himself his heirs executors and Administrators the said property unto  
the said Nathaniel Francis his heirs executors Administrators and assigns against  
the claim of her the said Hammett Whitehead her executors and administrat-  
ors and against the claim or claims of all and every person or persons  
whatever shall and will warrant and forever after them die these presents
