Love and affection which I bear to Nathaniel Francis of the County and
State aforesaid as well as for the further Consideration of bright husband and deliver
to me in hand paid by the said Nathaniel Francis at or before the sealing
and delivery of these presents the receipt whereof is hereby acknowledged
have given and granted and by these presents do give and grant unto the
said Nathaniel Francis his heirs executors administrators and assigns the
following property To wit: The Tract of land on which I live together
with its appurtenances belonging thereto Containing by survey Five
hundred and sixty acres be the same more or less adjoining the Land
of John G. Turner Richard Peter Joseph B. Danson Edwin Harris and
others also one Negro man Hubbard one Negro boy Budd one boy George
one Negro Woman Dinah and two Children Jane and Wallis one
Woman Winney and Child Bob and all the future increase of said Negroes
all my Stock of horses Cattle Sheep and hogs and all their increase
all my Crop of Corn fodder potatoes peas and Cotton now on and one horse
Cart Barrow and harness with all my farming utensils To have and
to hold all the aforesaid Land Negroes stock of every kind and their
increase with [redacted] before named unto him the said Nathaniel
Francis his heirs executors administrators and assigns forever and the said Harriet
Whitehead for herself her heirs executors and assigns the said property unto
the said Nathaniel Francis his heirs executors administrators and assigns against
the Claim of her the said Harriet Whitehead her executors and adminis-
trators and against the Claim or Claims of all and every person or persons
whatsoever shall and well warrant and forever defend them by these presents
