This Indenture made the 14<sup>th</sup> day of November in the year 1843 between  
William B. Person and Francis his wife of the County of Geethampton and State  
of Virginia of the one part and William Westray of the same County and State  
of the other part: Witnesseth: that the said William B. Person and Francis his  
wife in Consideration of One Hundred and forty dollars of lawful money of the  
Commonwealth to them in hand paid by the said William Westray and belief  
the executing and delivery of these presents: have bargained and sold and by  
these presents do and each of them doth bargain and sell unto the said William  
Westray his heirs and assigns a Certain tract of land lying and being in the  
County aforesaid and bounded as follows: Commencing at a Maple Corner tree  
between the said William B. Person Patrick Person and Lewis Allman thence  
by a line of marked trees between the said Person and Allman to a black  
juncus Corner between William B. Person Lewis Allman and the heirs of Mathews  
juncus and thence down the run of a large branch to where it empties  
into the Head spring of the Cypress swamp thence up the said swamp to the  
beginning; There being One hundred acres be the same more or less: To have  
and to hold the said land with every part and parcel thereof: with every of  
their rights unto the said William Westray his heirs and assigns forever: And  
the said William B. Person and Francis his wife for themselves and their heirs  
the said land unto the said William Westray his heirs and assigns free  
from the claims of William B. Person and Francis his wife and their heirs  
and all and every persons or persons whatsoever: shall well and do warrant  
and forever: defend by these presents. In Witness whereof the said William
