Burgoff the Creditor of the third part witnesseth that the said Joseph Sarnwell on the 7<sup>th</sup> day of June in the year of our Lord 1723 in view to receive the payment of the sum of Tenenty five hundred dollars to the said A. L. H. Burgoff did by indenture of lease of that date convey to the said A. L. H. Gain his heirs executors &c the following property to wit Land slaves & Chattels and his interest in the same of Mrs. Mellons upon trust for the use and purpose in the said indenture mentioned. And whereas since the executing and delivery of the said deed of lease the said A. L. H. Burgoff has made sale of the above property and A. L. H. Burgoff became the purchaser of a tract of land of 200 acres more or less also his interest in the slaves & Chattels estate of the dowry of Mrs. Mellons & his interest in 200 acres of land in right of said Sarnwell wife for the sum of 831 dollars and 4/100 parts which the said A. L. H. Burgoff hath bought and conveyed. Now this Indenture Witnesseth that for the Consideration aforesaid as well as for the further Consideration of one dollar in hand paid by the said Joseph Sarnwell to the said Thyegeon Gain at and before the executing and delivery of these presents the receipt whereof is hereby acknowledged by the said Thyegeon Gain have granted bargained and sold remised and Conveyed and by these presents do grant bargain and sell remise and Convey unto the said A. L. H. Burgoff all the estate right title interest claim and demand he hath or law and equity in or to the said Thyegeon Gain now held in the land and slaves above specified To have and to hold the said tract or parcel of land together with the several slaves and their increase of the same of the dowry of Mrs. Mellons to the only persons and heirof of him the said A. L. H. Burgoff his heirs executors administrators and assigns forever; and the said Thyegeon Gain for himself his heirs executors and assigns in as full and ample manner as the same was accustomed by the said Joseph Sarnwell by the deed of lease above recited do warrant and convey to the said A. L. H. Burgoff against the Claim or Claims of him the said Thyegeon Gain and all persons claiming by or under them or either of them (Notwithstanding) that the said presents hereunto set my hand and affixed my seal the 21<sup>st</sup> day of June first above written signed sealed & delivered in presence of
