Land aforesaid: To have and to hold the said tract or parcel of land to the said
Miles Spencer his heirs Executors and assigns forever: to the only proper use and behoof
of him the said Miles Spencer his heirs Executors administrators and assigns forever
And the said Thugers Laine for himself his heirs Executors and administrators the
above mentioned land unto the said Miles Spencer his heirs Executors administrators
and assigns in as full and ample manner as the same was warranted by the said
Miles Spencer by the deed of trust above recited do warrant the same to the said
