 Polly D. Williams & Spratley Williams hath for and in consideration of
 the sum of one thousand dollars to them in hand paid by the said Robert
 Ridley at or before the sealing and delivery of these presents the receipt
 whereof the said Polly D. Williams doth hereby acknowledge
 and thereof acquit and discharge the said Robert Ridley his heirs
 executors and administrators forever by these presents that the said Polly
 D. Spratley Williams hath granted bargained sold aliened released
 and confirmed unto these presents with grant bargains sell alien
 release and confirm unto the said Robert Ridley his heirs and assigns
 forever one certain tract or parcel of land situate lying and being on the
 County of Southampton aforesaid and bounded by the lands of Robert
 Ridley Joseph H. Bachman Estate of Conover Pease and Nancy Miller
 Pease Bachman & William Evans it being the tract or parcel of
 land given to the said Polly Donnell Williams by Mary Jarrow and as
 by her Deed bearing date the thirteenth day of April 1809 and recorded
 the twenty first day of August 1809 and more fully appears containing
 four hundred & four acres to the same man or left together with all
 houses out houses Edifices buildings woods ways water Cotters Water
 Lots gardens flocks Communitie hereditaments and appurtenances whatsoever

 executors and administrators touching & concerning the same premises so

 Robert Ridley & his heirs and assigns to the only further use and behoof
 of him the said Robert Ridley and his heirs and assigns forever and
 the said Polly D. I. Spratley Williams and their heirs the said plantation
 tract or parcel of land and premises hereby bargained and sold unto the
 said Robert Ridley and his heirs and assigns and to my and all of them
 against them the said Polly D. I. Spratley Williams and their heirs and
 against all and every other persons and person whatsoever shall and will
 warrant & forever defend by these presents for witness whereof the said
 Polly D. I. Spratley Williams hath to these presents set their hands and seals
