 dollars to him paid by the said Lemna Holt at and before the executing and delivery
 of these presents and in consideration of which he the D. Augustus Pipes have bargained
 and sold and doth grant bargain and sell unto her the said Lemna Holt all certain
 tract of land lying and being in the aforesaid County of Southampton and bounded to
 contain thirty one acres of land some bounded as follows: beginning at a post oak
 in John M. Keale line thence North to the N. W. corner line thence North to a
 Maple in the next branch @ corner on Harrison Pipes line thence up said branch
 to another Maple on D. Pipes line thence Pipe's line near South west to a pine standing
 on a mound forest thence D. Pipes line near a South course to the N. W. corner line thence
 thence line near @ South east corner to a pine @ corner of Cordy Pipes line thence
 D. Pipes line near South to a post oak line @ corner on 1830s Pipes line thence
