£ 1/100 Dollars hath having date on the 15 day of June 1764 the first payable on Demand and the other payable thirty day after date Interest from date to date which Note this aforesaid James of Dorset Charles W Barkham and Davis Baworth are the said Debt & Elizabeth Whiteley and the said Jacob B Binyant is further indebted unto the said James B Binyant in the sum of one hundred and twenty four dollars 25 cents by bond he hath having date December 31 1763 and payable January 1 1765 and being meeting and desirous to secure and provide for the payment of the aforesaid debt with the interest which may sooner thereon as well as to indemnify his said creditors he the said Jacob B Binyant has agreed to convey the Property herein after mentioned unto the said Elizabeth R Edwards in trust to be sold for that purpose Notwithstanding That Indentures Witnesseth that the said Jacob B Binyant as well for and in consideration of the forewaits as of this further consideration of one Dollar to him or her come paid by the said Elizabeth R Edwards the Receipt whereof is hereby acknowledged hath granted bargain'd and sold and by these presents hath granted bargain'd and sell unto the said Elizabeth R Edwards his heirs executors administrators or assigns the following property to wit a certain tract or parcel of land lying situate in the County of Westchester containing by estimation two hundred & fifty two acres more or less bounded by the lands of the Heirs of Gatz Binyant on the North side of the said being a part of the Rightways tract of land To Have and to hold the property aforesaid unto him the said Elizabeth R Edwards his heirs executors administrators or assigns forever UPON the following trust's conditions that at any time hereafter whenever the said James B Binyant or Gatz Binyant or their heirs shall think proper to collect the said aforesaid sum here or whenever the said James of Dorset Charles W Barkham & Davis Baworth shall deem to be Release from their debts & obligations it shall be the duty of the said Elizabeth R Edwards upon being thereto requested by the said James B Binyant or Gatz Binyant or James of Dorset & Davis Baworth or either of them their executors administrators or assigns to make date of this Property aforesaid or so much thereof as may be sufficient for the purpose at full value unto the highest bidder for cash and out of the Monies arising from such sale first pay and discharge all debts and expenses attending such sale and then conveyance then pay and discharge the said aforesaid sum the said James B Binyant with the interest which may have accrued thereon and the balance if any pay over to the said Jacob B Binyant but if the said Jacob B Binyant shall pay and discharge the said aforesaid sum the said James B Binyant has aforesaid with the interest due thereon and all costs attending the Indentures whereunto requested from the Indentures to be met or else to remain in full force and Effect whereby the said parties have here at their hands and affix their seals the day and year first aforesaid
