Now therefore the aforesaid Jonathan Humpf shall for and in consideration of the premises foreward and the further sum of five dollars and 50 cents due to the said John Williams forgives the 25th day of December 1844 and one dollar paid on hand to the said Jonathan by the said Mr. Hale this receipt whereof is hereby acknowledged. And the said Jonathan Humpf will grant warrant and take unto the said Mr. Hale his heirs executors administrators and assigns forever the following property to make the entire sum of three dollars and five cents that is on the aforesaid two bonds, leave one four bank notes to Humpf and to hold the aforesaid property one all the right like interests and estate whatsoever of him the said Jonathan Humpf of or to the same to him the said Mr. Hale his heirs executors administrators and assigns forever the tract hereinafter that of the said Jonathan Humpf shall until and truly pay and satisfy reckoning all the aforesaid sum of money due me or myself aforesaid with all the interest which may have accrued thereon to him to whom the same is justly due and owing on or before the 25th day of December next, then these these said documents and every other herein contained to be set off and if no effect, but if the said Jonathan Humpf his heirs executors or administrators shall not pay the said sum of money due and owing as aforesaid with all interest and cost which shall have accrued thereon on or before the 25th day of December next then aforesaid reckoning either of the said Jonathan Humpf or of the said John Williams his heirs executors or assigns the said Mr. Hale shall and may sell and dispose of the said property at public auction at the last house of the said County or elsewhere for money ready or by itself stamp as may be necessary for the payment of the said sum of money due and owing as aforesaid giving at least one months previous public notice of the time and place of sale by advertisement posted at the last house door of said County and that the proceeds of such sale after paying all cost attending the execution of this trust be applied by the said Mr. Hale to the discharge of this aforesaid sum due and owing as aforesaid or so much thereof as may then be due together with the interest and cost which shall have accrued thereon on the said property hereby conveyed shall be made at the time of the payment of the said sum of money interest and cost the said Mr. Hale is to return to the said Jonathan Humpf all this title theron hereby transferred to him and the said Jonathan Humpf for himself his heirs and executors with the said Mr. Hale his heirs is that the aforesaid property against the claim of all and every person or persons whatsoever will be held forever innocent and forever absolved of all and every claim or action for or upon the said property that the said Jonathan Humpf is to answer in respect of the aforesaid property until the day of the sale of the same above testimony whereof the said parties have hereunto interlocked their hands and affixed thereto the day and year first above written underneath.
