of Forty four dollars in hand paid by the said Jacob Barnes at and before the execution
and delivery of these presents the Receipt of which is hereby acknowledged have therefore
bargained and sold and by these presents doth herein and hereby convey to said Barnes all
the right title interest and estate which he the said Miles Piper has in and to a certain
lot and parcel of land situate to contain eleven acres be the same now or left the said
land lying in the County of Southampton and bounded by the lands of said Barnes
William Stephens & the lands formerly owned by James Worrell ad to have and to
hold the said lot and parcel of land forever free from the claim of him the said
Miles Piper his heirs and assigns forever and also free from the claim or demands of
any living other person or persons whatsoever which right title as aforesaid he the said
