 this instrument, now and the said Mills Paper being, willing and desiring to become the several
 debt and to be due to the said Richard Dorman. And this Anderson witnesses that
 for and in consideration of the sum of one hundred and for the further consideration of us then is to be
 the said Mills Paper we have paid by the said Bow & Paper at and before the making and
 delivery of these presents the sum of one hundred and forty dollars, which we the said Mills
 Paper here, gave in full payment for and for the said presents, debt you gave
 hereon and all with the said Bow & Paper his heirs and assigns forever as they have
 their duty bound of heirs and their future increase fifteen shillings and their increase fifteen
 hundred shillings and their increase two hundred and increase forever to be paid to the said
 Richard Dorman, three hundred and shillings two shillings, six pence and half pence for three and
 their future increase plantation and farming, always hereafter and his heirs forever after
 his the said Mills Paper entire interests in Belcher's Place Estate or the property now held by
 him, the Bow and to have to his the said Bow & Paper forever use and behoof forever
 upon trust, nevertheless that the said Bow & Paper shall at the request of either
 one of the several parties after giving, at least ten days notice of the time and place of
 sale sell at public auction all the several property or so much thereof as shall be sufficient
 to satisfy the said debt and costs and also of the several parts, by the said Anderson with
 them for the debt and interest due Richard Dorman and the balance of any part not
 then due the said Mills Paper or his legal representatives and the said Mills Paper hereby
