Third Article. Made and entered into this 1st day of November in the year of our Lord one thousand eight hundred & forty four between Adams Spury of the said parts Richard A. Wrightsby of the second party & for the remainder of the other party all of the County of Southampton & state of New Hampshire that the said Adams Spury for the consideration of the sum of two thousand & twenty five dollars fifty cents which said sum is due to the said Jas B. Wrightsby in the said income Spury by him bearing date the 15th of Sept 1843 as well as all other monies which may be due & owing from the said Adams Spury to the said Jas B. Wrightsby by reason of any damage damage of article or paper whatever at his present residence of one dollar to be in hand paid by the said Richard A. Wrightsby the receipt whereof the said Adams Spury doth hereby acknowledge shall give and discharge to the said Jas B. Wrightsby all his present debts heretofore owing to him & his representatives forever all his rights & interests in the following property to wit those lands & plantations two acres & three roods two acres & three roods all of my housekeeping buildings furniture of every description all of my right house garden & cellar one acre more or less. More of the meadow land small kept or held belonging to him the said Adams Spury to have & to hold with all the rights & interests of the said Adams Spury herein contained or intended to be conveyed to him the said Richard A. Wrightsby. His heirs & representatives forever except his special attorney notwithstanding that the said Richard A. Wrightsby aforesaid having these rights by the aforesaid Jas B. Wrightsby shall possess to tell all the rights interest of the said Adams Spury to the said Adams Spury hereby excepted or intended to be conveyed to him the said Richard A. Wrightsby his heirs & representatives forever for ten days after advertising the time & place in the said County of Southampton for ten days previous to some publick notice or stile for sale & all of the money arising out of sale of the said lands on the first floor being a salary all cost attending the said sale as well as the expense attending the said conveyance & then pay off the aforesaid land & interests & the hospital of my post to the said Adams Spury is the said Adams Spury for himself his heirs & the rights & interest to the said property unto the said Richard A. Wrightsby his heirs & representatives forever & hereby expressly agrees against his special attorney or friend of him the said Adams Spury has been and will again all and every other friend or friend whatsoever to the said Richard A. Wrightsby or his heirs & interests & agents that he will make sale of the rights & interests hereby excepted for to settle his own debts for the same after advertising the time & place for the day previous at some publick house or store in the said County of Southampton & with whom ever from the date first day & salve all costs attending the same as well as the

expenses attending the conveying the aforesaid property if any his party communicate and agree to the remittance of such interest as well as expenses by reason of any failure to these friends & agent who i allowed in payment of the same
