Now all Men by these presents that I James T. French with the consent and approbation of
Edward Harrison & William R. Edwards signified by their signing this instrument, comise release
French's conformat and do by these presents release & conformat unto William Griffis & Company
to his wife & certain undivided interest, in a tract of land containing one hundred and
fifty acres belonging to the estate of John Hobson late living & dead in the County of
Southampton being the entirety comprised by the said Griffis except in a certain tract
concluded on the 18th day of June 1842 to the said French for the benefit of the said Hobson
I Edwards and admitted to Record on the 25th June 1842 to Wm. Hobson the
aforesaid undivided interest unto the said Griffis & wife against the claim of them the
said French Harrison & Edwards & their claiming by through or under them only. I Wm. Hobson
whereof the said French Harrison & Edwards have herte set, their hands affixed thereto
seals this 10 day of January 1845.

This Indenture made this 17 day of January in the year of our Lord 1845
between Benj & Vick trustees of the forty fourth Harrison Estate after of the second party,
Joseph Pipe executors of the third party witnesseth the said Joseph Pipe, 4th day of March
in order to secure the payment of the sum of One hundred and twenty five dollars to the
said Harrison Pipe the 1st day of September of every year coming to the said Benj & Vick
his heirs Executors and trustees the following property (to wit) Sixty five and a half acres
of land 3 feather beds 2 pumtines one or 2 oaks & cedars one gun on long sharp 3 short sharp
one Gun & wheel and barre, all my clothing Materials up to Street for his uses & purposes
in the said undivided Harrison and others since the execution and delivery of the said deed
of trust the said Joseph Pipe hath fully delivered and paid to the said Harrison Pipe the
sum of money thereby directed which the said Harrison Pipe doth hereby acknowledge \$100.
Also the Undivided Wellingforth, land, for the construction expenses as well as for the further
construction of one dollar or less paid by the said Joseph Pipe to the said Benj & Vick as
and before the execution and delivery of these presents the receipt whereof is hereby acknowledged
by the said Benj & Vick unto the aforesaid and executors of the said Harrison Pipe signified
by his being party to these presents and the said Harrison Pipe hath granted bargained and
sold released, remised, abat and confirmed and by these presents do grants, bargains and sell releases
abat and confirms unto the said Joseph Pipe all the estate right, title interest, claims and demands
left of him and in respect which the said Benj & Vick Harrison Pipe have and had by the
said property above mentioned to have and to hold the said property
to the said Joseph Pipe his heirs Executors administrators and assigns to the only proper use
and behoof of him the said Joseph Pipe he having executed above and aforesaid power until the
time when Benj & Vick and Harrison Pipe for themselves there will be execution judicet' executed
