 Edwin Harrison & William R. Edwards signified by their signing the instrument, conveyed unto
 his wife & certain undivided interest, in & to lands of land containing one hundred and
 fifty acres belonging to the estate of John Holmes dec'd lying in the County of
 Southampton being the interest conveyed by the said Briggs unto & certain land
 conveyed on the 18th day of June 1839 to the said Edwards for the benefit of the said Harrison
 & Edwards and admitted to Record on the 23rd June 1839. To Have & hold the
 above undivided interest, and the said Briggs's wife against the claims of them the
 said French Harrison & Edwards & those claiming by through or under them (all) In Witness
 whereof the said Church Harrison & Edwards have hereunto set their hands & affixed their
 seals the 10 day of January 1845.

This Indenture Made the 19 day of January in the year of our Lord 1845
 between Bay & Piche Decease of the first part, Harrison Esq of the second part,
 Joseph Esq executor of the third part. WHEREAS the said Joseph Esq by deed of March
 in order to secure the payment of the sum of One hundred and twenty five dollars to the
 said Harrison Esq the 9th condition of trust of Italy date coming to the said Bay & Piche
 this heirs executors and assigns the following property (to wit) Twenty five and a half acres
 of land 3 further lots of water one or 2 creek's about one quarter of an acre & some other
 one half acre and some other all lying along between Upper Creek for the use & purpose
 in the said indenture mentioned and whereas now the execution and delivery of the said deed
 of March the said Joseph Esq hath fully satisfied and paid to the said Harrison Esq the
 sum of money thereby secured which the said Harrison Esq doth hereby acknowledge. Now
 This Indenture Witnesseth that for the consideration of one dollar as well as for the further
 consideration of no dollar we have paid by the said Joseph Esq to the said Bay & Piche all
 and before the executing and delivery of these presents the Receipt, showing is hereby acknowledged
 by the said Bay & Piche with the assent and approbation of the said Harrison Esq signified
 by his being party to these presents and the said Harrison Esq hath granted bargain and
 sold released released and conveyed and by these presents do grant bargain and sell release
 release and convey unto the said Joseph Esq all the estate right title interest claims and demand
 title of law and in equity which the said Bay & Piche Harrison Esq have and held in the
 said property above described to Have and to hold the said property unto
 to the said Joseph Esq his heirs executors administrators and assigns to the only proper use
 and behoof of him the said Joseph Esq his heirs executors administrators and assigns forever and the
 said Bay & Piche and Harrison Esq for themselves their heirs executors administrators
