This Deed of Release from J. R. Edwards & Wm. Schell to Peter Barker was acknowledged by said Edwards & Schell and admitted to Record

This Instrument made and entered into the 11<sup>th</sup> day of March 1845 between Peter Barker and Dolly his wife of the one part and Littleton R. Edwards of the other part whereby that the said Peter Barker and Dolly his wife & in consideration of the sum of five hundred dollars to them in hand paid by the said Littleton Edwards whereof he hereby acknowledges have granted bargained sold & confirmed and by these presents do grant, bargain sell and release unto the said Little Barker his heirs and assigns & certain tract or parcel of land lying and being in the County of Southampton and containing one hundred and forty four and one fourth acre more or less lying in the same wherein the said Barker now resides and bounded by the tract of John James Samuel & James Little (except Discovery) and Wm. Nicholson, Wm. Schell, Charles R. Langford with all and singular the appurtenances to the said tract of land belonging or in any wise appertaining. It is agreed and to hold the aforesaid tract of land and premises unto him the said Little Barker to be his & assigns to the city paper and wife of him the said Little Barker to be his & assigns forever and the said Peter Barker and Dolly his wife hereby do covenant and agree to & with the said Little Barker to have & that he
