Westcott doth of the one part and Nathaniel Francis of the other part both of the County of Southampton and state of Virginia Metropoli^t that the said Esau Bryant administrator of Samuel B. Westcott and by his attorney and forty acts of lawful ways of this instrument to have in trust paid by the said Nathaniel Francis at or before the rendering and delivering of this present receipt whereof a fully acknowledged sum of money and bills due by the present date longer and all unto the said Nathaniel Francis his heirs and assigns forever a certain tract or parcel of land situated lying and being in the County of Southampton and bounded as follows beginning at a Mopel at branch to corner for Schol Dykes in Nathaniel Francis has since the various corners of Branch to a rock south in the lower line of Henry Moore there to a west gulf or corner for Henry Moore a corner in back of line thence to a post rock a corner for the lower land in Henry Moore then to a pine a corner for Schol A.
