his wife have granted bargained & sold and by these presents do grant bargain & sell
unto the said Mathew Jones to his heirs and assigns a certain tract of land or parcel
of Land containing about hundred forty seven acres more or less by late survey lying and
being in the County of Buckingham State of Va. bounded as follows to wit Beginning
at corner of a line between Noses & Jones thence along said line to west end at
the Rock House to corner fence in said swamp thence along said swamp to corner fence
at Tongue Log line thence along said swamp as it runs to rocky swamp thence along
said swamp as it runs to Black Bend at A. S. Jones house thence along said swamp to
the Rock house along said Rock to corner Post oak by reference to the post to south
of said Rock boundaries will more fully show the tract and to hold in all and singular
the aforesaid premises belonging unto him and his heirs Mathew Jones his heirs and assigns
to the only proper use and benefit of him the said Mathew Jones his heirs and
assigns forever and we the said Edward Remond & Sons his wife the aforesaid tract forever
more fully the said Mathew Jones to his heirs and assigns and assigns as he said
Edward Remond & Sons his wife & all and every part of persons inhabitants shall & will
warranty and forever defend by these presents that nothing whatever in the said Edward
Remond & Sons his wife heirs & assigns shall affect this tract in the day and year first above written
signed sealed and delivered.
