This Indenture made the 30th day of January in the year of our late eighteen hundred and forty four between Robert S. Barnes trustee of the first part South Clerk of the said of the second part and Zachary Story of the third part all of the County of Southampton & State of Virginia whereas the said Clerk Jordan on the 23rd day of March in the year of our late eighteen hundred and thirty eight in order to secure the payment of the sum of his hundred and seventy two dollars & twenty five cts to the said Zachary Story did by Indenture of Debt of that date convey to the said Robert S. Barnes his heirs and assigns one certain tract or parcel of land situate lying and being in the aforesaid County of Southampton & State of Virginia containing fifty seven and three fifths acres but the same tract or left and bounded by the lands of John Benjamin Pelham Dickie tract the James Bagshaw and others agent Trust for the use and purposes in the said Indenture mentioned and whereas since the executing and delivery of the said deed of Trust the said South Clerk Jordan hath fully satisfied and paid to the said Zachary Story the aforesaid debt hereby secured where the said Zachary Story hath hereby acknowledged. Now This Indenture witnesses that for the consideration aforesaid as well as for the further consideration of one dollar in hand paid by the said Clerk Jordan to the said Robert S. Barnes at and before the making and delivery of these presents the receipt whereof is hereby acknowledged by the said Robert S. Barnes with the assent and approbation of the said Zachary Story signified by his being party to these presents and the said Zachary Story having granted bargain and sold with covenants warranties and confirmations and by these presents to grant bargain and sell secure release and confirm unto the said South Clerk Jordan all the estate right title interest claim and demand both at law and in equity which the said Robert S. Barnes and Zachary Story have or hold in the land above described. To have and to hold the said tract or parcel of land unto the said South Clerk Jordan his heirs executors administrators and assigns forever and for the only purpose and not belief of him the said South Clerk Jordan his heirs executors administrators and assigns forever and the said Robert S. Barnes and Zachary Story for themselves their heirs executors and assigns the above mentioned land unto the said South Clerk Jordan; his heirs executors administrators and assigns so as full and complete manner as the same are represented by the said South Clerk Jordan by the deed of Trust above recited to convey the land to the said South Clerk Jordan against the claims or claims of him the said Robert S. Barnes and Zachary Story and all persons claiming by or under them or either of them and to receive delivery of the parties to these presents have hereunto set their hands and affixed their seals the day and year first above written signed sealed delivered in presence of
