witnesseth that the said Augustus W. Hart, and wife for and in consideration of the sum of
eight hundred and no dollars in hand paid by the said John A. Person (the receipt whereof is
hereby acknowledged) have granted, bargained and sold and by these presents do grant bargain
and sell unto the said John A. Person his heirs and assigns no certain tract or parcel of land
lying in the County of Southampton supposed to contain three hundred and forty acres be-
ing the same here or his and adjoining the lands of the said Person William S. Brown and
others together with all and singular the appurtenances to the said tract of land belonging
in anywise appertaining to them and to hold the tract of land aforesaid unto him the
said Person his heirs and assigns forever and the said Hart and wife hereby agree to warrant
and defend the title above conveyed unto the said Person his heirs or assigns, notwithstanding
the said Hart and wife and their claiming by through a under them but against the claim or
