This Indenture made and entered into on this 27th day of June in the year of our last aforesaid hundred and forty four between Henry Bishop of the County of Southampton & State of Virginia of the one part and John Bishop of the same County and State of the other part Testifyeth that the said Henry Bishop for and in Consideration of the sum of eighty dollars Current Money of the Commonwealth to him in hand paid by the said John Bishop which he before the making and delivery of these presents the receipt whereof is hereby acknowledged hath granted bargained sold aliened conveyed and confirmed unto and by their heirs and assigns with full power not certain tract or parcel of land situate lying and being in the aforesaid County of Southampton and parish of Saint Pauls containing by estimation fully more or less than being the tract or parcel of land the said Henry Bishop purchased of John Thompson and bounded by the lands of said Henry Bishop James Willard John Thompson's Willard Allen's estate together with all right title interest claim or demand of us and to the aforesaid tract or parcel of land and premises and its appurtenances thereto belonging or in any wise appertaining do have and to hold the above described tract or parcel of land with all and singular its appurtenances thereto belonging unto and to the said John Bishop his heirs and assigns forever to and for the only proper use and behoof of him the said John Bishop to and for the only use and behoof of him the said John Bishop his heirs and assigns forever and the said Henry Bishop for himself his heirs Executors and assigns do hereby covenant and agree to and with the said John Bishop his heirs Executors assigns and assigns that he will by the presents warrant and forever defend all the right and title of the aforesaid tract or parcel of land and premises and on every part a parcel thereof against the claims or demands of and every person or persons whatsoever.
