J. Griffin of the first part, Nathan S. Williams of the second part and William Beale
 & Abraham Roddick of the third part whereas the said Nathan S. Williams on the
 25th day of June year 1845 in order to secure the payment of the two sums of \$100
 and \$200 the said Nathan S. Williams the said William Beale and Abraham Roddick did by indenture of lease of land of that

date convey to the said Jonathan J. Griffin his heirs Executors and assigns
 certain lands conveyed by the said Nathan S. Williams to the said William Beale
 or his assigns of John Barrell late of North Carolina and perhaps Henry D. Engstrom
 as agent land for the use and purpose in the said indenture mentioned and whereas
 since the execution and delivering of the said deed of land the said Nathan S.
 Williams has fully satisfied and paid to the said William Beale & Abraham Roddick
 the sums of money thereby secured which the said William Beale & Abraham Roddick
 do hereby acknowledge have these Indentures witnesses that for the consideration
 expressed as well as for the further consideration of one dollar in hand paid by the said
 Nathan S. Williams to the said Jonathan J. Griffin at and before the executing
 and delivery of these presents the receipt whereof is hereby acknowledged by the
 said Jonathan J. Griffin with the assent and approbation of the said William Beale &
 Abraham Roddick signified by their long parties to these presents and the said William Beale
 & Abraham Roddick having granted bargained and sold unto the said Nathan S. Williams
 by these presents the grant bargain and sell unto the said Nathan S. Williams all the estate right title interest claim demand debt at law and
 equity which the said Jonathan J. Griffin William Beale and Abraham Roddick have or
 hold in the lands above described to have and to hold the said tract or parcel of
 land to have the said Nathan S. Williams his heirs Executors administrators and assigns
 forever to the only purpose and intent of him the said Nathan S. Williams his heirs
 Executors assigns forever and the said Jonathan J. Griffin for himself his heirs
 Executors and assigns as a full and ample manner as the same was warranted
 by the said Nathan S. Williams by the deed of land above recited do warrant the
 same to the said Nathan S. Williams against the claim or claims of him the said
 Jonathan J. Griffin William Beale and Abraham Roddick and all persons
 claiming by or under them or either of them save except whereof the parties
