This Indenture made this 27th day of October 1845 by and between Jonathan
 J. Griffin of the first part, Nathaniel Williams of the second part and William Beale
 Suffern and Abram Roddick of the third part, whereas the said Nathaniel Williams on the
 23rd day of June year 1845 in order to secure the payment of the two sums one for
 Williams \$231.25 the other sum of \$75.67 the sum of \$286.92 in the year 1845 to the
 said William Beale and Abram Roddick did by indenture of land of that
 date convey to the said Jonathan J. Griffin his heirs Executors &c the following
 described lands conveyed by the lands of Joseph Woodruff Meigs Esqr the heirs
 or assigns of John Barrell late of North Carolina & perhaps Henry D. Ferguson
 as agent land for the use and purpose in the said indenture mentioned and whereas
 since the execution and delivery of the said deed of land the said Nathaniel
 Williams has fully satisfied and paid to the said William Beale & Abram Roddick
 the sums of money hereby secured which the said William Beale & Abram Roddick
 do hereby acknowledge now these parties do hereby certify that for the consideration
 of record as well as for the further consideration of one dollar in hand paid by the said
 Nathaniel Williams to the said Jonathan J. Griffin at and before the execution
 and delivery of these presents the receipt whereof is hereby acknowledged by the
 said Jonathan J. Griffin with the assent and approbation of the said William Beale &
 Abram Roddick signified by their being parties to these presents and the said William Beale
 & Abram Roddick having granted bargained and sold, released and conveyed and
 by these presents do hereby grant bargain and sell, release and confirm unto the said
 Nathaniel Williams all the estate right title interest claim demand debt at law and
 equity which the said Jonathan J. Griffin William Beale and Abram Roddick have or
 hold in the lands above described to have and to hold the said tract or parcel of
 land to have the said Nathaniel Williams his heirs Executors administrators and assigns
 forever to the only purpose and intent of him the said Nathaniel Williams his heirs
 Executors & assigns forever and the said Jonathan J. Griffin for himself his heirs
 Executors and assigns to release the above mentioned land unto the said Nathaniel Williams his heirs
 Executors and assigns as if full and ample manner as the same was warranted
 by the said Nathaniel Williams by the deed of land above recited & warrant the
 same to the said Nathaniel Williams against the claim or claims of him the said
 Jonathan J. Griffin William Beale and Abram Roddick and all persons
 claiming by or under them or either of them save & except whereof the parties
