and described more by the name of the said town tract of the second part all
of the County of Southampton the Wiltshire that the said John Parker and
Nathan W. Vaughan Esq. as joint lessees have for and in consideration of the sum of
five hundred and ten dollars and fifty cents to claim in hand paid the receipt
whereof is fully acknowledged bargained and sold unto the said joint lessees
and delivered and confirmed unto the said James Vincent his heirs and assigns
