Scarsdale at and before the recording and sealing of these presents do hereby declare and acknowledge having bought and paid for all the land and property of the said Russell S. Scarsdale which he had in his possession and under his title and also for all the furniture household and personal property of the said Russell S. Scarsdale which he had in his possession and under his title and also for all the debts and expenses due and owing to the said Russell S. Scarsdale by the said Thomas Pardridge and T. E. his wife aforesaid the right and title to the above granted land and premises to the said Russell S. Scarsdale his heirs and assigns against the claim of the said Thomas Pardridge and T. E. his wife and their heirs and assigns the claim or claims of all and every other person whatever shall well and truly appear and prove except by the present I'll witness above the said Thos Pardridge and T. E. his wife aforesaid have bound with their hands and affix their seals the day and year first above written
