 do hereby acknowledge as my part here granted bargained sold and by these  
 presents do grant bargained sold aliened and confirmed unto the said  
 Nicholas S. Wright and to his heirs and assigns all the Improvement the said  
 tract of land being in the County of Southampton and State of Virginia containing  
 two hundred acres by the same more or less and bounded as follows on  
 the east by several swamps on the north by the lands of George R. Hammett  
 and on the west by Petty Branch and others so far as to hold the said  
 tract of land with appurtenances unto the said Nicholas S. Wright his heirs  
 and assigns forever Now witnesseth the said parties to these presents  
 have executed and delivered this day and year above mentioned  
 in liquidated damages in
