P. Wright & Rosanna his wife in hand paid (or agreed to be paid) at or before
the executing and delivery of this present the receipt whereof is hereby
acknowledged to have granted Bargain and Sale and by these presents doth
grant Bargain and sell unto the said Lewis Griffon his heirs and assigns
for ever a certain tract a parcel of Land lying thereby in the County aforesaid
containing by estimation eighty acres more or less and bounded by the Lands
of Mrs. Betty Branch and Nicholas P. Wright, and Lewis Griffon make all
and singular the appurtenances thereto belonging or in any wise appertaining to
the same or any part or parcel thereof unto the said Lewis Griffon his heirs and
assigns forever and the said Nicholas P. Wright and Rosanna his wife for their
deter their heirs & unto the said Lewis Griffon his heirs executors administrators
and assigns to have warrant and power defend the right and title to the above
named tract of Land from the claim or claims of them and all and every person
or persons whatsoever claiming or demanding the same or any part or parcel thereof. In
