recording and delivery of this present instrument, whereof he hereby acknowledges the  
same and doth and by these presents do and make of them debts, dues, arrears  
and still unto the said Charles E. Knight, his heirs and assigns forever certain  
tract or parcel of land lying and being in the aforesaid County of Southampton  
containing twenty six acres. By the same more or less adjoining the lands of William  
Warren Jonathan Director and the heirs of Elviro Warren and his heirs with all the  
right, title, interest, or claim or demand of me and to the above described tract or  
parcel of land and premises with all and singular its appurtenances advantages profits  
and whatsoever hereditaments or belonging or in any way appertaining unto him the said  
Charles E. Knight his heirs and assigns forever and every part and parcel thereof to  
have and to hold the said tract or parcel of land with the hereditaments  
and all and singular the premises heretofore mentioned or intended to be so  
granted and held and every part and parcel thereof with every of their rights
