

This Indenture made this 15th day of January in the year of our Lord Christ, One thousand eight hundred and forty seven, Nathaniel Bradshaw and Amy of Bradshaw of the County of Southampton and State of Virginia of the one party, and Abridgton Bradshaw of the same County and State of the other party, Witness that the said, Nathaniel Bradshaw and Amy & his wife for the consideration of the sum of One hundred & 25 dollars 144^{cts} good and lawful Money of Virginia to them in hand paid by the said Abridgton Bradshaw the receipt whereof is hereby acknowledged made by their private grant bargain sell convey and confirm and by their private last granted bargain and sell unto the said Abridgton Bradshaw to him and to his heirs forever, One certain tract or parcel of land and premises situate lying and being in the County and State aforesaid containing by estimation One hundred and fifty six and 1/2 ac the same more or less (to wit) Beginning at a place in a small branch of 25 of Nathaniel Bradshaw & Abridgton Bradshaw's above said 2^d branch to Benjamin Bradshaw Will point thence up the said Will point the various course thereof to the Mying branch thence up the Mying branch the various thereof to Dons Hole creek way thence along said branch to a corner of Dons Hole in 2^d Branch thence S 13. W 50 poles to a situation point thence on the various course of a light road to the Road thence down the Road 66 poles thence to the beginning again with all houses out houses raifers buildings yards gardens Orchards ways waters and water course whatsoever belonging or in any way appurtenant to the 2^d branch or parcel of land and premises to have and to hold the said land unto the said Abridgton Bradshaw to him and to his heirs forever And the said Nathaniel Bradshaw and Amy & his wife for themselves their heirs executors Administrators and assigns both by their private covenants and agree to and with the said Abridgton Bradshaw his heirs and assigns that they will by their private Warrants and process defend all right title claim or demand of any person claiming or demanding the same or any part or parcel thereof And Witness that of the said Nathaniel Bradshaw and Amy & his wife their hands and affixes this date this day and date before written
