This Indenture made and entered into on this 8th day of December in the year of our lord righteous hundred and forty five between Nancy B. Somo of the County of Southampton State of Virginia William S. Roche and Julia S. Roche his wife of Hartsford County State of North Carolina all of the one party and Henry Somo of the said County of Southampton State of Virginia of the other party Witnesseth that the said Nancy B. Somo William S. Roche and Julia S. his wife for and in consideration of the sum of \$500 Dollars Current Money of the Commonwealth of Virginia to them in hand paid by the said Henry Somo at or before the making and delivery of these presents the Receipt whereof is hereby acknowledged have granted bargained and sold and by these presents do and each of them doth grant bargain and sell unto them the said Henry Somo his heirs and assigns forever all their right title and interest of in and to one certain tract or parcel of land and premises (situated lying and being) in the aforesaid County of Southampton and parishes of Saint Andrew containing by estimation one hundred and thirty acres (be the same less or less) it being the tract or parcel of land which was conveyed to the said Nancy B. Somo & Julia S. Roche formerly Julia S. Somo and their brothers and sisters by Mary Swearing in her last Will and testament and whereon the said Henry Somo now resides and dwells by the lands of the said Henry Somo Adams and others do have and to hold all the aforesaid right title and interest of them the said Nancy B. Somo William S. Roche and Julia S. his wife granted to the said described tract or parcel of land and premises with all and singular the appurtenances thereto belonging or in any wise appertaining unto them the said Henry Somo his heirs and assigns forever to and for the only proper use and behoof of him the said Henry Somo his heirs and assigns forever And the said Nancy B. Somo William S. Roche and Julia S. his wife for themselves their heirs executors and administrators covenant and agree to and with the said Henry Somo his heirs executors and assigns that they will by their presents warrant and forever defend all their said right title and interest of in and to the aforesaid tract or parcel of land and premises against the claims or demands of all and every other person or persons whatsoever save the Wilsons whosoever the said Nancy B. Somo William S. Roche and Julia his wife have hereunto set their hands and affixed their seals the day and year first above written
