Powell and Mary Jane his wife of the County of Southampton & State of Virginia of the one party and Mike Warrall of the same County and State of the other party Witnesseth that the said Joseph B. Powell and Mary Jane his wife for and in consideration of the sum of five hundred dollars current Money of the Commonwealth to them in hand paid by the said Mike Warrall at and before the making and delivery of these presents do and each of them doth grant bargain and sell unto him the said Mike Warrall his heirs and assigns forever One certain Tract or parcel of Land and premises situate lying and being in the aforesaid County of Southampton and Parish of Saint Luke containing by survey three hundred and seven rods be the said more or less it being said Mary Jane portion of the Land owned by herself and Joseph B. Powell in the division of the lands of Lewis Warrall and which has since been divided between them and bounded by the Lands of Thomas Newson Ernie Vick and others together with all right title interest claim or demand of or unto the above described tract or parcel of Land and premises with the appurtenances thereto belonging or in any way appertaining. I O HAVV said to HOLD the aforesaid tract or parcel of Land and premises with all and singular the appurtenances thereto belonging as aforesaid unto him the said Mike Warrall his heirs and assigns forever to and for the only proper use and behoof of him the said Mike Warrall his heirs and assigns forever and the said Joseph B. Powell and Mary Jane his wife for themselves their heirs Executors and assigns do and each of them doth hereby covenant and agree to and with the said Mike Warrall his heirs Executors assigns and assigns that they will by their presents Warrant and force defend all the right and title of the aforesaid tract or parcel of Land and premises and every part and parcel thereof against the claims or demands of all and every other person or persons whatsoever.
