Shelby & State of Tennessee of the one part and Nathaniel B. Bryant of the
County of Southampton in the State of Virginia of the other part, Witnesseth
that the said John D. Turner wife Lucy C. Bryant wife Mary Bryant for
and in consideration of the sum of five hundred and fifty dollars to them in
hand paid by the said Nathaniel B. Bryant before the sealing and delivery of
these presents the receipt whereof is hereby acknowledged have granted bargain
and sold and by these presents do grant bargain sell and confirm unto the
said N. B. Bryant his heirs and assigns a certain tract or parcel of land lying
and being in the County of Southampton in the State of Virginia bounded by the
lands of Sampson C. Reed Nathaniel Jones and others and containing by estimation
two hundred and thirty acres by the same more or less together with all and
singular the premises and appurtenances whatsoever to the said tract or parcel of land
belonging or in any wise appertaining to have and to hold the premises above
conveyed and to have the said N. B. Bryant his heirs and assigns to the only proper
use and behoof of him the said N. B. Bryant his heirs and assigns forever And said
John D. Turner and wife Lucy C. Bryant and wife Mary Bryant for themselves
their heirs & hereby covenant with said N. B. Bryant his heirs & that they and
their heirs of a fee simple estate in the tract of land above conveyed and that they
will warrant and forever defend the same unto him the said N. B. Bryant his
