the Receipt Whereof is hereby acknowledged both granted bargained aliened
enjoyed confirmed and sold unto the said Charles E. Knight his heirs and assigns
forever one certain tract or parcel of Land lying and being in the County and
State aforesaid containing one hundred and eighty acre or to the said more or less
lying on the North side of the Chapel Road and boundary the Land of Capt
Barne John M. Roale Thomas Newson and the heirs of Holliday Powell due
together with all the right title claim interest or demand of in and to the above
described tract or parcel of Land and the premises with all and singular
its appurtenances thereto belonging or in any wise appertaining unto him the said
Charles E. Knight his heirs and assigns forever to and for the only proper use and
benefit of him the said Charles E. Knight his heirs and assigns forever and
the said Cephalus S. Powell for himself his heirs executors administrators
covenant and agree to and with the said Charles E. Knight his heirs and assigns
that he will by these presents Warrant and forever defend the right and
title of the aforesaid tract or parcel of Land and the premises and every
part and parcel thereof against the claim of him the said Cephalus S. Powell
and every person or persons whatsoever the Witness Whereof the said
Cephalus S. Powell has hereunto set his hand and affixed his seal this day
and year first above written
