

This Indenture made and entered into this 10<sup>th</sup> day of July in the year four  
 and one thousand eight hundred and forty seven between Septhak E. Powell of the  
 one part and Charles E. Knight of the other part all of the County of Southampton  
 and State of Virginia Witnesseth that for and in consideration of the sum of  
 three hundred dollars to him the said Septhak E. Powell in hand paid by the  
 said Charles E. Knight at or before the making and delivery of these presents  
 the Receipt Whereof is hereby acknowledged hath granted bargained aliened  
 conveyed confirmed and sold unto the said Charles E. Knight his heirs and assigns  
 forever one certain tract or parcel of Land lying and being in the County and  
 State aforesaid containing one hundred and eighty acre or thereabouts  
 lying on the North side of the Chapel Road and bounded by the Lands of Sicut  
 Barne Colton to Neale Thomas Newson and the heirs of Holliday Powell and  
 together with all the right title claim interest or demand of in and to the above  
 described tract or parcel of Land and the premises with all and singular  
 its appurtenances thereto belonging or in any wise appertaining unto him the said  
 Charles E. Knight his heirs and assigns forever to and for the only proper use and  
 behoof of him the said Charles E. Knight his heirs and assigns forever and  
 the said Septhak E. Powell for himself his heirs executors administrators  
 covenants and agrees to and with the said Charles E. Knight his heirs and assigns  
 that he will by these presents Warrant and forever defend the right and  
 title of the aforesaid tract or parcel of Land and the premises and every  
 part and parcel thereof against the claim of him the said Septhak E. Powell  
 and every person or persons whatsoever His Witness Whereof the said  
 Septhak E. Powell has hereunto set his hand and affixed his seal this day  
 and year first above written
