Surley of the second part, and Jonathan Dardot of the third part, all of the County of Southampton Whereas the said Robert Revell is lawfully indebted to the said Jonathan Dardot by bonds carrying interest from the 1st day of January 1847 for the sum of two hundred & fifty dollars as well as another debt due by bond which last mentioned debt certain personal property has been conveyed by deed of trust to secure the payments but should the property therein conveyed be insufficient to pay & satisfy the debt cost & interest there and in that event the property hereafter named is assigned to secure the balance thereof which debts and the legal interest thereon according the said Robert Revell is willing and desirous to secure Now this Indenture Witnesseth that for and in consideration of the premises and also for the further consideration of one dollar in hand paid by the said Selah M. Surley at and before the sealing and delivery of these presents the Receipt whereof is hereby acknowledged by the said Robert Revell hath given granted bargain and sold aliened enfeoffed and confirmed and by these presents doth give grant bargain sell alien suffe release and confirm to the said Selah M. Surley his heirs and assigns forever all that tract or parcel of Land lying & being in the County of Southampton containing 180 acres by the same thereof before for the full description of said Land referred may be had to a deed of bargain & sale from Jonathan Dardot & wife Selah Ellsworth trustee & David Rich of N. which deed is of Record in the Clerk's Office of Southampton conveying the above described Land to the said Robert Revell with all & singular the appurtenances to the said tract or parcel of Land belonging and any now appertaining and all the estate right title and interest to the said Robert Revell in and to the said granted or intended to be hereby granted tract or parcel of Land and premises to have and to hold the said hereby granted or intended to be hereby granted tract or parcel of Land and premises with its appurtenances unto the said Selah M. Surley his heirs executors administrators and assigns forever to the only proper use and behoof of the said Selah M.
