This INDENTURE made and entered into on the 15th day of March in the year 1847 by and between William Vick Jacob Porter and Elizabeth Porter his wife of the one part and Isiah Vick of the other part both party of the County of Southampton in the State of Virginia this Indenture witness whereof that they the said William Vick Jacob Porter and Elizabeth his wife have for and in consideration of the sum of Sixty Dollars to them in hand paid by the said Isiah Vick at the rendering and delivery of this present the Receipt, of which is hereby acknowledged and in consideration of which they the said William Vick Jacob Porter and Elizabeth his wife have by these presents granted bargained and sold and do and make of their said grant Begrant and sell unto the said Isiah Vick all and every of their right title interests and estates of in and to the portion of Land on which Peter Vick widow of Anna Vick did now live also three other acre allotted to the widow the same being in law of donor in said descendants lands containing nine and one half acre by said survey lying in the said County of Southampton in the parish of Saint Luke St. Laver and to Hobart rock and all other rights title interests and estates so aforesaid unto him the said Isiah Vick his heirs and assigns forever that is to say after the death of the said Lydia Vick stirs to the sole use and benefit of him the said Isiah Vick his heirs and assigns forever free from its claim of either William Vick Jacob Porter or Elizabeth his wife or either of their heirs or assigns which includes and take as aforesaid that the said William Vick Jacob Porter and Elizabeth his wife do hereby warrant and defend against whomsoever their heirs and executors and administrators shall sue or make suit for or against them or either of them or either of their heirs or assigns the Writs whereof they the said William Vick Jacob Porter and Elizabeth his wife have hitherto set their hands and affixed their seals the day and year first above written signed sealed acknowledge and delivered in presence of
