This Indenture made the 12th day of March year 1847 between Benjamin
Bunn of the first part Cordy Pope of the second part and Jacob Barnes of
the third part Witnesseth that Cordy Pope on the 14th day of April year
1840 in order to secure the payment of One hundred and fifty dollars due to
the said Jacob Barnes did by Indenture of Trust of that date convey to
the said Benjamin Bunn his heirs executors &c the following property to wit
a certain tract or parcel of land lying and being in the aforesaid County
of Putnam and bounded by the Lands of the following named person
to wit Jimmy Worrell late the Widow of James Worrell and Thomas James
Augustine Pope Wm Pope and the above named Jacob Barnes and
supposed to contain One hundred and fifty acres of Land more or less
Upon Trust for the use and purpose in the said Indenture mentioned
and Whereas since the Execution and delivery of the said deed of
Trust the said Cordy Pope hath fully satisfied and paid to the said
Jacob Barnes the said sum of One hundred and fifty dollars thereby
secured which the said Jacob Barnes doth fully acknowledge that this
Indenture Witnesseth that for the consideration aforesaid as well as for
the further consideration of One dollar in hand paid by the said Cordy
Pope to the said Bunn at and before the making and delivery of
their parents the Receipt whereof is hereby acknowledged that he the
said Bunn with the assent and approbation of the said Jacob
Barnes signified by his being party to their parents and the said Jacob
Barnes have granted bargain'd and sold annu'd released and confirm'd
unto the said Cordy Pope all the estate right title interest claim and demand
both at Law and equity which the said Benjamin Bunn hath or hold
in the Land above described To have and to hold the said tract or
parcel of Land to the said Cordy Pope his heirs executors administrators
and assigns forever to the only proper use and behoof of him the said
Cordy Pope his heirs executors administrators and assigns forever and the
said Benjamin Bunn for himself his heirs executors the above
mentioned Land unto the said Cordy Pope his heirs executors adminis-
trators and assigns in as full and ample manner as the same was warranted
by the said Cordy Pope by the deed of Trust above recited do Demand
