heirs & assigns from myself my heirs & Wifey my hand and seal this day

This Instrument made this 12th day of March year 1847 between Benjamin
Bunn of the first part Coody Poppe of the second part and Jacob Barnes of
the third part Witnspk that Coody Poppe on the 14th day of April year
1840 in order to secure the payment of One hundred and fifty dollars due to
the said Jacob Barnes did by Indenture of trust of that date convey to
the said Benjamin Bunn his heirs Exec &c the following property to wit
a certain tract or parcel of land lying and being in the aforesaid County
of Southampton and hundred by the name of the following named person
to wit Jimmy Wornell late the Widow of James Wornell and Thomas Neeson
Augustus Poppe Wm. Poppe and the above named Jacob Barnes and
supposed to contain One hundred and fifty acres of Land more or less
Upon trust for the use and purpose in the said Indenture mentioned
and whereas since the execution and delivery of the said deed of
trust the said Coody Poppe hath fully satisfied and payed to the said
Jacob Barnes the sum of One hundred and fifty dollars thereby
secured which the said Jacob Barnes doth fully acknowledge Note this
Instrument Witnspk that for the consideration aforesaid as well as for
the further consideration of one dollar in hand paid by the said Coody
Poppe to the said Bunn at and before the making and delivering of
this present the Recpt whereof is hereby acknowledged that he the
said Benj. Bunn with the aupt and approbation of the said Jacob
Barnes signified by his being party to these premises and the said Jacob
Barnes have granted bargained and sold remised released and confirmed
unto the said Coody Poppe all the estate right title interest claim and demand
both at Law and equity which the said Benjamin Bunn have or shall
in the Land above described to have and to hold the said tract or
parcel of Land to the said Coody Poppe his heirs Executors Administrators
and assigns forever to the only for ever use and behalfe of him the said
Coody Poppe his heirs Executors Administrators and assigns forever and the
said Benjamin Bunn for himself his heirs Executors Administrators the aupt
Mentioned Land unto the said said Coody Poppe his heirs Executors Administrators
and assigns in as full and ample manner as the same was warranted
by the said Coody Poppe by the virtue of trust above mentioned Warrant
