This INDEMNITY made this 17<sup>th</sup> day of April, year 1847 by and between  
Candy Pope and Sunny Pope his wife of the one party, and Emma Holt of the  
other party each party of the County of Southampton in the state of Virginia  
Witnesseth that the said Candy Pope and Sunny his wife in consideration of  
one hundred and twenty dollars lawful money of Virginia to them in hand  
paid by the said Emma Holt at the making and delivery of this present to  
the Receipt Whereof is hereby acknowledged have bargained and sold and by  
these presents do make each of them sell bargain and sell unto the said Emma  
Holt her heirs and assigns a certain tract or parcel of Land lying on the  
North west side of the Rail Road the center of said Road being in part the  
boundary of said land the dividing by the said Road the lands of said  
Pope after which bounded by the lands of the following named persons to wit  
James Warren of James Thomas Warren said Emma Holt witness Pope and  
Jacob Barrett which boundaries is supposed to contain eighty acres of Land the  
Matthews lot as to the parties whether more or less of said land together with  
all the appurtenances and emoluments in any way attached or situated on the  
said tract or parcel of Land to have and to hold the said tract or parcel  
of Land with the humours hereditaments and all and singular other the premises  
hereinbefore mentioned or intended to be bargained and sold and every part  
and parcel thereof with each of their rights and appurtenances to the said  
Land belonging or pertaining unto her the said Emma Holt her heirs  
and assigns forever to and for the only proper use and benefit of her the said  
Emma Holt her heirs and assigns forever with the said Candy and Sunny  
Pope his wife for themselves and their heirs the said tract or parcel of  
Land with all and singular the premises and appurtenances before mentioned  
unto the said Emma Holt her heirs and assigns first from the claim of  
claims of them the said Candy Pope and Sunny his wife or either of the
