This Indenture made this 17th day of April year 1847 by and between
 Cordy Pope and Ginny Pope his wife of the one part and Simon Holt of the
 other part each party of the County of Southampton in the State of Virginia
 Witnesseth that the said Cordy Pope and Ginny his wife in consideration of
 one hundred and twenty dollars lawful money of Virginia to them in hand
 paid by the said Simon Holt at the making and delivery of these presents
 the Receipt Whereof is hereby acknowledged have bargained and sold and by
 these presents do and each of them do bargain and sell unto the said Simon
 Holt her heirs and assigns a certain tract or parcel of Land lying on the
 north west side of the Rail Road the center of said Road being in part the
 boundary of said land the dividing by the said Road the lands of said
 Pope after which bounded by the lands of the following named persons to wit
 James Worrell of James Thomas Russell said Simon Holt William Pope and
 Jacob Barnes which boundary is supposed to contain eighty acres of Land the
 Mathews not as to the parties whether made a top of said Land together with
 all the appurtenances and emblements in any way attached or situated on the
 said tract or parcel of Land to have and to hold the said tract or parcel
 of Land with the tenements hereditaments and all and singular the premises
 herebefore mentioned or intended to be bargained and sold and every part
 and parcel thereof with each of their rights and appurtenances to the said
 Simon Holt his heirs and assigns forever and for the only proper use and behoof of her the said
 Simon Holt her heirs and assigns forever and the said Cordy and Ginny
 Pope his wife for themselves and their heirs the said tract or parcel of
 Land with all and singular the premises and appurtenances before mentioned
 unto the said Simon Holt her heirs and assigns free from the claim or
 claims of them the said Cordy Pope and Ginny his wife or either of them.
