Butler for and in consideration of the sum of twenty dollars to him in hand paid by the said Nancy H. Jordan at and before the sealing and delivery of these presents the receipt whereof is hereby acknowledged both granted, bargained and sold, and by these presents both granted, bargained and sold unto her the said Nancy H. Jordan her heirs and assigns forever one certain tract or parcel of Land with premises situate lying and being in the aforesaid County of Southampton & parish of Saint Luke containing by estimation four acres or thereunto or less it being the Land conveyed in a deed of Trust by Jacob Jordan to secure a debt due to William D. Butler which was sold under the said deed of Trust and purchased by said Benjamin D. Butler and bounded by the Lands of John Hargrave and Robert A. Barnes. To have and to hold the above described tract or parcel of Land and premises unto her the said Nancy H. Jordan her heirs and assigns forever to and for the only proper use and behoof of her the said Nancy H. Jordan her heirs and assigns forever and the said Benjamin D. Butler for himself, his heirs, Executors and assigns with hereby covenant and agree to and with the said Nancy H. Jordan her heirs Executors Adors and assigns that he will by four several warrants and former defend all the right title interest claim or demands of in and to the aforesaid tract or parcel of Land and premises against the claims or demands of all and every person or persons whatsoever Int.
